### **Comprehensive Immigration Reform**

### Adult Basic Education (ABE)

ABE includes General Educational development, basic education for adults who lack a high school qualification, and English for Speakers of Other Languages (ESOL). These services are provided by a variety of community based organizations that provide adults with the skills required to support their families and contribute to their communities. Not enough funding has been allocated to these programs and this creates long waiting lists for English classes in Massachusetts.

### **College Access for Immigrant Students**

Without access to financial aid and required to pay more than three times the amount as their fellow classmates, many high achieving immigrant students are unable to attend college. The In-State Tuition Bill would allow immigrant students who have attended a MA high school for at least three years to pay in-state tuition rates at state colleges and universities if they prove that they will apply for citizenship as soon as they are eligible.

#### **Health Care Reform**

In April 2006, the Massachusetts State Legislature passed a sweeping health care reform bill. However, some people are still not covered by this new legislation and implementation is still to be determined.

### Anti-Immigrant Legislation

On June 26<sup>th</sup> of this year, Senator Tarr and other Republican and Democrat legislators filed a bill entitled "To Promote Fair Employment and Security in the Commonwealth" (Docket # 2718), which would have far reaching negative consequences for Massachusetts. This bill would burden the state with new, complicated and costly immigration law enforcement activities that are currently the responsibility of the federal government, scapegoating immigrants based on their race and national origin. It will delay or even prevent employment for most workers in the Commonwealth, regardless of citizenship. This bill would also endanger public safety by diverting local law enforcement attention from people committing crimes to those that have immigration violations.

This in turn would have severe consequences for immigrant and refugee victims of domestic violence and their children.
